

# KEY CITIES CONSERVATION CLUB

## PROPERTY & RANGE RULES

1. Only current paid members, spouse, dependents under 18 (incl. foster children) and grandchildren may use ranges. **\*(see below)**
2. **NO** alcoholic beverages consumed prior or during the handling or use of any firearms on club property.
3. When other people are shooting or using the ranges, do not let children or pets run loose.
4. An uncased or un-holstered firearm will be unloaded, with the action open and visible or utilizing a chamber flag, when not in use or others are down range.
5. No firearms may be handled at a shooting bench, rest or station while anyone is down range tending to a berm or targets
6. No un-holstered, loaded firearms should be carried down range when checking or placing targets.
7. Shoot only in the ranges designated for the type and caliber of firearm you are using. No rifles or pistols on the trap range (other than those that can fire shot shells). No firearms on archery ranges. Only pistols or pistol calibers are allowed in the enclosed pistol berm. Only pistols or pistol calibers are allowed in the bullet traps.
8. Magazines/Clips should not be inserted in a firearm, or a round chambered, until you are at your firing position AND the firearm is pointed down range at a backstop, berm or other intentional and approved stop.
9. Use the rear perimeter benches of the shooting shelter when doing firearm maintenance or when field stripping a firearm for cleaning. Please do not use the picnic table or shooting benches.
10. Only **approved targets, (see below)** will be used and all target material must be picked up and disposed of properly.
11. Pick up your empty shell cases (including .22 rim fire). Remove from club property or place in the appropriate container.
12. Before firing, make sure of your line of fire and beyond are clear and safe with no animal or person in the down range area.
13. All targets must be in front of and **NOT** on top of or set higher than the backstops and berms.
14. Use sportsman courtesy when people are waiting to shoot and share the ranges as to benefit all.
15. Eye and ear protection **is required** for everyone on the shooting ranges and general area that a firearm is fired.
16. Use of fully automatic firearms is allowed when used under the following restriction:
  - A. Firearm must be eligible for individual ownership and on the ATF's Curio & Relics list.
  - B. Firearm must be in the possession of the registered owner at all times.
  - C. Firearm must have a butt stock and be shoulder mounted fired. **NO MACHINE PISTOLS.**
  - D. Target and point of aim must be no higher than 2 feet off the ground.
  - E. Firearm must be shot at the 50yard berm only and from a distance no greater than 25 yards.
  - F. Use is limited to 30 rounds per minute.
  - G. The member using a fully automatic firearm must give range priority to all other members **NOT** using fully automatics. H. Use of this firearm type cannot interfere with other members' use of the shooting range.
17. Only firearms designed to be handheld or shoulder fired are approved, no cannons, mortars, etc.
18. All ammunition expended must be recorded on range cards located in small mailbox on the shotgun and handgun/rifle range.
19. Shooting hours: 9:00 AM until sunset.
20. No shooting during any club meetings held on club property.

**\* Non-members on club property constitutes as criminal trespass. If caught trespassing while escorted by a club member, that member will forfeit their membership. Anytime you are on club property, you must have your membership card prominently displayed on your person. Failure to do so will constitute trespassing and possible forfeiture of membership.**

### Range Approved Targets

1. Targets used for club organized events, including but not exclusive to: Bowling pins (pin shoots) or Clay targets (trap)
2. Standard targets such as paper, cardboard, clay pigeons, Aluminum cans and plastic bottles. (Remove all targets when done)
3. Commercial manufactured pepper poppers, gongs, dueling trees, etc, when used according to manufacturer's instructions.

### Non-approved Targets

1. Glass of any kind
2. Appliances and household items of all kinds
3. Large chunks of metal or material not specifically designed as a target or that increases the chance of a ricochet
4. Any containers under pressure such as LP tanks, spray paint, expanding insulation, or which leaves a semi or permanent residue.
5. Tannerite or any explosive or flammable material

### Range Users Responsibilities

1. Abide by all the range rules
2. Use safe range practices
3. Prevent ricochets
4. All targets provided by members are to be removed when done shooting. This includes the 200-yard targets!
5. Take all garbage home. (Paper and wood can be put into the burn barrel provided.)
6. Pick up all cartridge casings and deposit in appropriate buckets.
7. Record all ammunition expended on range cards in small mailbox
